Rules and Conditions

Aims and Objectives	To promote interest, participation and excellence in theatre in the region, and engage regional creatives with Goulburn Performing Arts Centre		
Eligibility	Open to all community theatre groups, secondary schools, drama studios and other organisations with an interest in theatre on condition that the performers from these organisations receive no payment for their participation in the production being performed.		
Sections	Junior Section	All performers must be 25 years and under at time of performance.	
	Open Section	All ages	
	Original Script	Performance of an unpublished script or original work – not previously performed	
Adjudication	One Act Wonders is a competitive event although groups are encouraged to view the event primarily as an exchange of ideas, skills and friendship between people with a common interes in theatre.		
To Participate	•	for one-act plays and any theatre piece, published or unpublished. All t a full script – this is for the Judges only.	
	2 FORT reserves the right to reject or disqualify any play.		
	3 While every effort will be made to schedule performances to accommodate any requests for a particular time, this may not always be possible.		
	4 Goulburn Performing Arts Centre's Staff and Technical crew remain in charge of all facilities at all times and all participants must follow all reasonable directions of GPAC staff.		
	5 The decision of the Judges is final.		
Duplication	If two groups nominate the same play. Both groups will be informed that there are two entries and that each can choose to either continue with their nominated play or choose a second piece within 7 days of being notified.		
Licences and Copyright	Groups are required to submit a copy of the appropriate licences or, at the very least, proof that application has been sought. Companies are also responsible for paying applicable royalties.

	Open Section	Not less than 8 minutes and no more than 12 minutes	
	Junior Section	Not less than 8 minutes and no more than 12 minutes	
	Original Script	Not less than 12 minutes and no more than 18 minutes	
	Time allowed for –		
	Set-Up	5 minutes maximum	
	Strike	5 minutes maximum	
	All companies will be expected to observe these time limits and, further, abide by their nominated running time.
